Club members are permitted to bring up to nine guests on the premises at any one time, and the club member must be in attendance with his or her guests. In addition, a *bona fide* club member may hold a private function, such as a wedding, anniversary, bar mitzvah or similar social function at which all of his or her guests are permitted to be served alcoholic beverages. The club member shall be responsible for all charges or fees incurred by their guests, as well as for the conduct of each guest and the members of the guest's family while on the facility's premises.
